Professional Correctional Nursing Practice

February 2021

These past few weeks, controversy has erupted over the COVID-19 available vaccines, and who should receive them. While different states are approaching the immunization schedules differently, in all states the timing of the immunization of incarcerated persons has been a debated topic. The latest information (disclaimer: it does change daily) is that the COVID-19 case rate is four times higher in state and federal prisons that in the general public, and since March 2020, at least 227,333 incarcerated persons have tested positive and at least 1671 have died. In addition, at least 54,496 prison correctional staff have tested positive, and 105 deaths have been reported. According to the draft state proposals for immunization "roll-out" submitted to the Centers for Disease Control last Fall, 15 states had correctional staff prioritized in Phase 1, while only eight states had incarcerated persons included in Phase 1. Disconcertingly, seven states did not include correctional staff in any phase and 10 states did not include incarcerated persons in any phase.

We all should consider the facts and form our own opinions about who should have access to the vaccine and when. I encourage you to read articles and listen to newscasts (both pro and con) regarding the immunization of incarcerated persons and us, individuals who willingly enter correctional facilities daily to provide care and custody to this vulnerable population, with the ultimate goal of protecting our communities, and make your own decision. Be ready to share it when asked (and perhaps even when not asked...)! Remember that our <u>Correctional Nursing:</u> Scope and Standards of Practice mandates that we are patient advocates.

It is with great pride in our profession that I share with you that a few weeks ago the American Correctional Nurses Association was approached by ABC News to comment about COVID-19 immunization and the incarcerated population. Mary Muse, our Parliamentarian, was interviewed on camera as our representative. The YouTube version of the newscast is here.

reaching, even if it is not always evident as we care for our patients. I have


